### 6/19 <u>REFURBISHMENT</u>

It was agreed that the following works would be undertaken once consent from WBC has been received that the cost of the works will be approved within the provision of clause 6.2 of the lease and will be re-imbursed in accordance with the lease.

- a) The course of bricks at each entrance be reduced by a height of eight bricks
- b) New Wallgate unit in each toilet facility
- c) Decorating the two metal gates (ladies and mens' entrance) and the repainting of the disabled toilet door

Additional works to obtain quotes on the following:

- a) Heaters in each toilet facility
- b) Running costs of the heaters to be reviewed with Town Clerk
- c) Installation of a heating supply to each toilet facility

d) Lighting in each toilet facility
