16/19 AMENDMENT TO MANAGEMENT PROCEDURES

The current management procedure allows existing plotholders two weeks to decide whether they wish to exchange their plot for a newly vacated plot on the same site. Given the waiting list is so long, and it is unusual for exchanges to be made, it was suggested by the Deputy Town Clerk to reduce this period to one week.

In addition, the procedure requires that when a plot is offered to the waiting list it is offered to one person at a time. This has caused long delays between a plot becoming vacant and being taken up by someone on the waiting list either because people higher up the list have moved away or changed contact details and not notified the Council. It was suggested a vacant plot be offered to all the waiting list for a period of one week and at the end of the week offered to the highest responder.

Anyone who responds to the offer but is not successful will maintain their place on the waiting list. Anyone failing to respond to the offer will have one more offer before they are moved to the bottom of the waiting list.

<u>Recommended:</u> existing plot holders are given one week to inform the Council of their wish to exchange their plot for a newly vacant plot.

Recommended: the procedure is changed to offer a vacant plot to the waiting list in one go.
