- c) Wild flower meadows: there was discussion about management and maintenance of wild flower meadows and how poorly maintained the WBC wild flower meadows appeared

36/18 WAVERLEY BOROUGH COUNCIL MAINTENANCE CONTRACT

Deputy Clerk updated the committee and confirmed the three areas being considered. WBC will not consider handing over the freehold of the areas **Action:** Deputy Clerk to email Matt Lank at WBC with maps and/or details of specific locations of work, with costings to see whether WBC will agree to our proposal.

a) Table tennis tables – the grounds work is commencing on 16 July and Cllr Dear confirmed he is happy to meet the contractors on site to re-confirm the positioning of the tables and the re-positioning of the two picnic benches

Action: Deputy Clerk to order the tables and matting with a delivery date after 23rd July 2018

- Football nets have been bought and need to be put up
 Action: Cllrs Odell, Dear and Round to meet on 15th June and put the nets up
- c) Boulders we now have confirmation from WBC that these can be funded out of S106 money
 - **Action:** Deputy Clerk to order and arrange for delivery in situ

WAR MEMORIALS

a) Haslemere – having chased for nearly two months the result of the petrochemical observation by the geologist have come through. This needs to be considered and, in view of the possible sum involved in replacing and repairing the stone and repainting of the names, a proposal is go to Full Council

Action: Cllr Round and Deputy Clerk to meet to discuss and prepare proposal

- b) Hindhead the contractor, Kemp & Stevens, is donating a new plaque for the dedicatory text. The works should be completed by the end of June. The committee would like to record it's thanks to Kemp & Stevens Action: Deputy Clerk to write to Kemp & Stevens in due course
- c) Shottermill the contractor, Haven Memorials, has confirmed the works should be completed by the end of June

38/18 ALLOTMENTS

- a) Sturt Road no issues, one plot holder about to get a warning letter
- b) Collards Lane no issues
- c) Clammer Hill the car park has been strimmed and the noticeboard is up. Letters have gone out to four plots holders confirming they need to improve their plots. One new plot holder has inadvertently cultivated the wrong plot. As the plot had been in a very bad state anyway, and the owner had previously been written to, it was agreed that the new plot holder could keep the plot he has cultivated. The previous owner can have the plot that should have been cultivated.

Action: Deputy Clerk to write to the party who had not been looking after his plot to inform him of the swap and to confirm he has a month to get the new plot up to scratch.
