6/18 LION GREEN

a) Youth shelter repainting and repair

Action: A working party of Cllrs Peel, King, Abeysundara and Round to meet on site discuss so that the tables can be purchased in good time for the warmer weather

- d) Wooden posts at Lion Green and in front of the Apple Tree:
 - Action: 3 boulders are purchased and placed opposite the entrance to M&S as a traffic restraint measure and any existing good wooden bollards be moved and used in and around the green area in front of the Apple Tree
- e) Stream at Lion Green: Cllr King gave an update and confirmed that whilst the stream is currently free flowing, the local residents are quick to notify the Town Hall officers and Shottermill Ward councillors of any stream blockages preventing them from using the footpath. It was felt that it was time to find out who had responsibility for the stream once and for all.

Action: Deputy Clerk applies to Land Registry for title registers to identify owners of the land on either side of the stream

<u>Action:</u> To include, if not already done so, in any HTC contractor's contract for Lion Green that when required they will clear the stream alongside Lion Green of identified blockages

<u>Action:</u> that any update or ongoing issues can be brought back to the Amenities Committee

The safety of underground concrete water storage tank was also discussed as it appears the one of the metal bars Haslemere Town Council put across it has been deliberately benc. There is concern that this has been discussed for 10 years but HTC have been unable to do anything to make it safe because it is not their responsibility.

Action: Cllrs Round and Abeysundara and the Deputy Town Clerk meet an appropriate contractor on site to discuss options for making the tank safe.

7/18 WAVERLEY BOROUGH COUNCIL MAINTENANCE CONTRACT

The trial maintenance contract with Waverley Borough Council ends on 31 March 2018 and WBC would like to enter into a formal agreement with us to continue.

Deputy Clerk gave an update in relation to revenue and capacity at the sites:

Collards Lane – 3 payments outstanding and all plots rented

Sturt Road - 0 payments outstanding and all plots rented

Clammer Hill - 1 payment outstanding and three plots vacant.

Following a site inspection at Clammer Hill, it was noted the Town Orchard was looking overgrown. A weekend clear up is being planned by the Allotment Association and Cllrs Peel, Odell and Round expressed an interest in going along to assist.
