2020 to 2023 CHRISTMAS LIGHTING TENDER

Thank you for the inviting Light Angels to tender for the Christmas Lights in Haslemere, Weyhill and Hindhead. The tender is for a contract length of four years with a maximum budget per annum of £23,000.

We are proud to have been chosen as Haslemere Town Council's Christmas Lighting contractor for the last five years. Our priority was always to provide you with an installation service that is carried out professionally and on time. During this time I have worked alongside my installation teams I have a very good knowledge of the town that can only be gained from involvement with the installation teams.

We can supply NRSA: New Road and Street Act 1990 certification however it is not recognised by the HEA (Highway Electrical Sector Academy) who are the administrator of HERS (Highway Electrical Registration Scheme) and essential to comply with the Surrey County Councils 'Code of Practice'.

Services and other

Light Angels comply with the Surrey County Council and SKANSKA "Code of Practice"

Light Angels will submit to the Surrey County Council the correct paperwork to obtain the Festive Display Street Lamp Attachment Licence

Call outs are be included during the display period unless issue caused by external force beyond your control, copy of our Term & Conditions is enclosed version 2020v13.

As part of our services we will liaise with SKANSKA during the display period should there be any issue with the lamp post column

I have enclosed our Health & Safety Policy Statement, on page 6 is our Environmental Policy Statement.

Over the last few years we have been involved in a variety of tasks in Haslemere and surrounding area from regular banner installs for various fetes and fairs, flag and bunting installations in particular in 2016 for our Queens 90th birthday. When the Mayor of Haslemere David Round needed to hop into the bucket of our cherry picker to repair the flag pole fixings we were happy to help out. They are many 'other' uses for a cherry picker and the most unusual was to provide lift the Archdeacon of Surrey to the top of St Christopher's Church tower to bless the new flag pole.

Banner post testing:

I have received a competitive quotation for the testing of the four banner posts. They are a known supplier and use Non-Destructive Testing methods including Eddy current inspection to determine % loss of wall thickness at ground level and below ground.

If column has a swage joint they will use an Ultrasonic Inspection to detect any cracks. These findings are used to calculate the unit factor to establish if the column is structurally capable of having the banner or other attachments attached.

The company's price for this work is £575.00 and includes all travel costs, full inspection report with calculations and inspection certificate. The testing of columns and banner posts is part of many Code of Practices for many County Councils now. With this in mind I have been advised that I may get a reduction if others customer arrange to have their columns tested on the same day as Haslemere Town Council.

Finally you have requested a price per 10 metres for the supply and installation of icicles lights on buildings within the town. I am pleased to confirm that for one of longer length icicles with a drop of 60cm a 10 metre length supplied and installed is £139.50. The colours available are bright white or warm white LED. This price is for the popular mains voltage 230v icicle lights.

Please let me know I can be of any further help or you need additional information. I have enclosed a USB file with copies of the documents we have presented to you for Haslemere Town Council's Christmas Tender process.
