WA/2022/01308 - LAND COORDINATES 487607 137907, HYDE LANE, CHURT FARNHAM

The committee unanimously agreed to object to this application on the following grounds:

1) Inappropriate development within the Green Belt. No very special circumstances have been given to outweigh the harm done to the Green Belt contrary to policy RE2 of the Local Plan Part 1, policy 1.2 of the Haslemere Neighbourhood Plan and NPPF paragraphs 147 & 148.

62/22 <u>Decisions and Appeals</u>

The list was noted.

63/22 <u>Highways Update</u>

Susan Day and her two colleagues updated the committee on the works SGN are due to undertake.

<u>Phase 1</u> will be investigative work on the lower Hindhead Road and commence 6 June and continue for 10 days, which will start under two way auto green lights but may have to change to traffic convoy arrangements depending on road space.

<u>Phase 2</u> will be mains replacement work on the lower Hindhead Road which will start 5 September after the school holidays. Once phase 1 has completed SGN will have a better idea of what this will entail and how the traffic will be managed. It is anticipated the work will be done under two way lights.

<u>Phase 3</u> will be connection work at Tyndalls and commence during the October half terms and require a hard closure of the Hindhead Road for 9 days. The connection needs to take place before winter 2022 to ensure the integrity of the new main installed and minimise the impact of any potential leaks.

Cllr David Harmer spoke to the committee about the impact on the surrounding area when Hindhead Tunnel is closed. He has obtained a copy of the original report which detailed how Highways England would deal with closures, tunnel fires and diversions and the truth differs considerably. He would like to propose changes to Highways England with Haslemere Town Council's input.

<u>ACTION</u>: Highways working group to be set up to look at the data relating to closures and put forward proposals – Cllrs Round, Robini, Keen, Whitby and Dear. To consult with Thursley Parish Council
