Current projects

- Link footpath on Church Lane – Cllr Robini reported that he is meeting Surrey Highways officers shortly to discuss options and hopes to report at the next meeting
- Refuge at Tanners Lane – Cllr Robini reported Surrey Highways will not entertain the idea as the road is not wide enough because of much needed residents parking. It was agreed to remove this item from the current projects list
- Double recycling waste bin is due to be installed at Lion Green within the next few weeks.

### General projects

- Improvements to cycle and pedestrian pavement on the Hindhead road has been completed by a third party, assumed to be the utilities company who has been carrying out extensive roadworks

### Long term projects

- Cllr Round to make contact with Surrey Highways officers to discuss his transport proposals

#### **15/22 Projects – application by Hindhead Playing Fields Association**

The committee reviewed the application by for a grant of £5,000 towards improvements of the Pavilion. There are four sports clubs that use the pavilion – Beacon Hill Football Club (juniors and seniors), Hindhead Cricket Club and Churt Cricket Club. There is a lot of community support for the project, which will be delivered within the CIL spending deadline. There is already grant funding in place, and no previous CIL funding has been granted. There is evidence of public benefit of health, sustainable transport and social terms.

**Recommended** the granting of £5,000 subject to agreement by Full Council on 24 March 2022.

#### **16/22 Committee terms of reference**

The committee agreed the amendment to the Terms of Reference and voted to add “any sum over £5,000 requires authorisation by Full Council”.
