Name of organisation	Haslemere Community Station (HCS)

What will the revenue grant money be used for – please be as specific as possible and use a separate sheet if necessary.	Haslemere Community Station is requesting a grant of £2,500 from one of its key strategic partners, Haslemere Town Council. This will enable HCS to continue to employ a part time volunteer coordinator (Information Hub Manager) and social media project promotor for the Information Hub, which is situated on the forecourt of Haslemere Railway Station. This is of course, the principal transport Hub in Haslemere and situated in a highly visible position. The Information Hub Manager, manages a team of over 30 volunteers, including Duke of Edinburgh students who do a fantastic job to welcome local residents in search of community information and importantly provide information to rail users arriving at the station.
What specific benefits for the Haslemere community do you expect will result from the grant? ²	Promoting Haslemere as a visitor destination and supporting the businesses and vitality of the town is a key mission for the town council. HCS provides visitor information and a community resource at the key, strategic location in the town, as well as a growing social media outreach. As the Information Hub is manned in the main by a team of volunteers- a relatively small grant to employ the part time project coordinator / Hub Manager, presents excellent value for money, while raising the profile of the town. Another key role is to supervise HCS projects. The last one completed at the beginning of October 2022, promoted

Haslemere as a rail destination, with information for onward bus travel into the local Surrey Countryside. I.E The Punch Bowl and Frensham Ponds etc. HCS's current project, is to bring the Haslemere Signal Box into community use. It becomes redundant in the autumn of 2024 and it will then be restored to its original circa 1890's operational status and be used as a 'working' museum for the benefit of both the local community. This will become a tourist attraction in its own right. We have agreement from Network Rail that they will transfer the signal box to HCS at a peppercorn rent and we are in conversation with the Railway Heritage Trust to provide funding for this particular project. HCS operates out of a shop on the station forecourt that has been modernised and enlarged by South Western Railway and also given to us at a peppercorn rent. When the signal box becomes a community asset, this shop will also become the

focal point of the signal box project.

Application procedure

No application will be considered by the Committee unless the applicant is able to confirm all of the Validity Checklist criteria. If in doubt contact the Town Clerk 01428 654305.

Consideration and notification

The application will be considered by the Grants Committee generally for capital expenditure only and on a matched funding basis.

The Committee meets every two [2] months. Successful applicants will be informed by letter/email as soon as possible thereafter.

Payment procedure

A grant payment will only be made by the Town Clerk against production of an original invoice or invoices for goods or services made out to the recipient organisation. Under no circumstances will payment be made to an individual.

Payments are made by cheque/BACS therefore the recipient organisation must hold a bank account in the name of the organisation.

Grants should normally be drawn down in one amount. The Grant Letter will state that the grant will automatically lapse if it is not claimed within the time specified.

As a courtesy, a reminder letter will be sent to the applicant organisation one [1] month before the expiry of the grant advising that the funds have not yet been claimed.
