Justification for increase in Grant funding:

- £5k grant paid by HTC every year since 2011-12
- Cost of fuel increase £5k additional fuel operating cost per month 2022 versus 2021
- Wage and NI cost increases min wage now £9.59 per hour (hoppa paying £10.00 per hour) Gap to min
 wage shrinking and struggling to recruit
- Waverley Borough Council grant reduced by 15% since last year
- hoppa strategic aim to roll out Concessionary fares across Waverley (currently £3.00 each trip in Haslemere)
- Hoppa strategic aim to move to net zero with Electric buses requires additional funding and infrastructure
