### **45/23 Apologies for absence**

The committee accepted the absences of Cllr Arrick (prior appointment).

### **46/23 Declaration of Interests**

### **50/23 Amenities Terms of Reference**

The amendment was agreed. It was also noted that the public toilets at Lion Green should now be added to the committee remit.

### **51/23 Fences at Lion Green & Town Meadow**

The committee discussed this issue at length and there are still some concerns about safety both at Lion Green and Town Meadow. A further discussion, and possibly site visit, will need to take place with the Councillors who raised issues. It was thought that natural barriers, such as stinging nettles, along the Lion Green stream will do the job of deterring young children for accessing the stream where the concern arises. At Town Meadow, a single ranch fence across the newly cleared stream could be an option.

**ACTION:** The Chairman and Cllr Austen to liaise with Martin Wellen about solutions, and costings.

**RECOMMENDATION:** The Chairman and clerk are delegated to make a decision, with any financial implication being in accordance with the Financial Regulations, such funding to come out of the Amenities budget.

**52/23 Handrail from Lower Street to Sandrock**
