The committee positively **supports** this application and has asked the Clerk to write to Waverley to confirm.

The committee commented on the poor quality of the plans supplied by the Applicant. In addition, it was very disappointed to note that it will cause loss to a hedge line which will impact on biodiversity, contrary to policy H9 of the Haslemere Neighbourhood Plan & DM1 of the Local Plan Part 2.

**SC/2023/01432 & 01433 LAND COORDINATES 487607 137907 HYDE LANE**

The committee discussed this application. It is believed the agroforestry building has already been erected and is subject to enforcement action. The committee supports the position of Waverley Borough Council.

**89/23 Short term lettings/Air BnB**

Cllrs noted the suggestion given by Waverley Planning Enforcement officers and will signpost any residents who have concerns about unauthorised short term lettings/AirBnB letters to Waverley's website to complete a breach of planning control form.

**90/23 Highways Update**

Cllr Robini was asked (as the Surrey County Councillor) when the Petworth Road was going to be resurfaced. He advised that it is in the pipeline but has no knowledge of timing, which is down to funding.

Cllr Keen advised that the grass cutting undertaken by Surrey CC contractors at Sunvale Avenue & Oak Tree Lane has resulted in the arisings ending up in the drains. Surrey needs to be notified and contractors told to address the issue otherwise the drains end up blocked.

Cllr Carter updated the committee about the recent meeting with Cllr David Harmer (Surrey County Councillor for the Western Villages division which Hindhead is part of). The blocked drains on the A287 have been reported and are now on a priority list, together with a request that an overall speed reduction strategy be looked at for Hindhead & Beacon Hill. SCC are in the process of reviewing all speed limits across the County, so until they get to Hindhead/Beacon Hill it has been asked that car speeds along Clovelly Road be looked at as a matter of priority.

**91/23 Licensing application**

The application for a new licence at The Cabin, Lower Street Haslemere was noted. No objections were put forward.

**92/23 Street Trading licensing application**

The street trading licence for High Street, Haslemere was noted. No objections were put forward.
