7. Summary of the project proposal	<p>Shottermill Junior School is located in Haslemere within walking distance for many families and local residents. Due to the location of the school and extensive range of outdoor and indoor facilities our school is a popular choice for external organisations to host activities/clubs. Our facilities include, woodlands, art room, dance studio and an all-weather astro pitch. We have regular lettings with organisations within the local community and these include football clubs and the Haslemere Youth Centre (A Place To Be). We also over holiday clubs run by Koosa Kids– which are part of the HAF scheme, offering free places to free school meal families.</p> <p>We would like to apply for funding for the installation of flood lights on our all-weather astro pitch. Due to the pitch not having any external lighting, the pitch cannot be used by community lettings during the autumn/winter months and this is a real disadvantage as we know that the pitch is very popular with children attending the clubs. Due to the increasing financial pressures within schools and limited funding we are unable to fund the project.</p>

Once installed it will be possible to run after school sporting events for the Haslemere schools.</p>

What evidence is there of support from the community</p>	<p>Local clubs who hire the school premises have shown interest in using the astro pitch during the winter months e.g. JK Coaching, Haslemere Youth Club (A Place to Be) and Koosa Kids (holiday childcare provider that offers free places to Free School Meal pupils – HAF scheme). If floodlights are installed then clubs will be able to use the facility and benefit those children/young people.</p>
<p>15. Proposed timescales for the project</p>	<p>Timescales are estimated to be fairly short/medium – within 1 – 3 months for the project to be completed. This will involve getting quotes, confirming a contractor and having the works carried out.</p>
