8.10 In The Vision Zero Strategy writes about training children aged 7 and above on how to walk safely. This is putting the onus of safety on the child rather than the driver. A child of 7 should not be expected to hold that risk responsibility. This is similarly true when mandating high visibility clothing. If a child forgets to wear a high vis and there is an accident, is it their fault for forgetting the safety gear or the driver who hit them? Children cannot reliably assess speed below about 12 years old and assessing (any) risk is impaired throughout the teenage years.
