What aspect of the project will grant money be used for. Please be as specific as possible. ²	<p>Supply of and Installation of CCTV equipment at Grayshott Sportsfield Pavilion and Surrounding area.</p> <p>The project is required as a consequence of the vandalism and damage the club has received to its assets over the last 12 months. Ongoing damage to our modern outdoor net facility and an attempted break in to our garage where expensive equipment is housed.</p> <p>The club has already taken a number of preventive measures at its own cost to reduce the risks of such events. These measures include enhanced locking system for our nets and painting of anti vandal paint on the net cage surround.</p> <p>As a consequence of the attempted break in, a new roller door had to be fitted – cost circa £2k</p>
What benefits for the Haslemere community do you expect will result from the project? ³	<p>A high proportion of our approaching 474 members are from Haslemere and surrounding areas. 29% with a GU27 post code and a further 24% from GU26 post code area. Installation of CCTV equipment will further reduce likelihood and risk of third party damage and theft, thereby minimising membership fees and inevitable inconvenience when such events occur to all members and our volunteers who ensure the smooth running of the club.</p>
