#### 5/24 SMALL GRANT APPLICATIONS FOR CONSIDERATION

#### Grayshott Cricket Club - £750

## Project description: CCTV installation.

The committee discussed the pros and cons of the installation of CCTV at this venue. One view put forward was that CCTV is a deterrent to the type of criminal vandalism that the club has been experiencing and should be supported. It was also suggested that the money could be better spent on increased security measures such as better locks since police were unlikely to investigate any thefts and all that was likely to come out of CCTV was a set of photos. There was also a question over whether the council should be funding CCTV on private premises and whether granting this award would open the floodgates to other applications.

Cllr Robini asked that the cricket club should be reminded that they comply with all regulations, including data protection, when installing the CCTV. They also need to ensure that the images are actually recorded.

**<u>RESOLVED</u>**: That the full amount of £750 is awarded to Grayshott Cricket club for the installation of CCTV.
