STURT FARM SANG – GROUNDS MAINTENANCE

BACKGROUND

- The following schedule is from the SANG Management plan referred to in the lease between Stonewater & Haslemere Town Council.
- Please note it has been agreed by Ecology Solutions who prepared the plan that the quarter sward cut should not refer to Jan-Feb but later in the year.
- Highlighted green is grounds care, yellow is tree care, and blue is removal of waste.
- This note relates to grounds care only.
- We will be obtaining quotes for the annual tree inspection separately and please note any resulting tree management will have to be done on an ad hoc basis.
- As it is a new area of management for both the Council and it's contractors it is proposed that we review both the management plan for the SANG and the maintenance after the first year.

<u>RECOMMENDATION</u>: Commercial Grounds Care maintain the SANG land in accordance with the principle of the management plan and the practical considerations of the site at a cost of £9,901 for the first year.
