7. GRANT OF LEASE TO HASLEMERE PUBLIC SERVICES LIMITED

Committee to note the following:

When the council took over the running of Haslemere town centre Public toilets in 2017 it was advised that by taking on a second property, it would become liable for full business rates on the town hall as well as the toilets. We currently enjoy a significant small business rates reduction because of a 'one building' rule. The lease for the High St toilets was therefore granted to Haslemere Public Services Ltd, a company set up by the Council for that purpose, as advised by our legal representatives. The Town Clerk, and Clirs Carter and Keen are currently the directors.

The same issue has been raised with the completion of the new toilets on Lion Green. The advice from our lawyers was to grant a short lease/licence in favour of Haslemere Public Services Ltd and this has been done by the town Clerk after consultation with the Chairs of F&G and Amenities.
