What benefits for the Haslemere community do you expect will result from the project? ³	<p>Churt & Hindhead Cricket Club [CHCC] is the fastest growing juniors club in this area and aims to introduce more girls and women to the sport. Of the 300 members 70 are girls and 20 women. We aim to become the best local cricket club in the area measured by local participation across all demographics.</p> <p>A level surface will reduce the slip, trips and falls hazards and reduce the potential for the ball to bounce unevenly and strike a player or spectator. Risk of injury is a significant deterrent to children , girls and women from taking up the sport.</p> <p>The grounds are shared with the football club and this roller will speed up ground preparation allowing more of the grounds to be used by increased numbers of players, more frequently.</p> <p>Our goal is to improve the surface which will increase the appeal to all generations and genders, in particular juniors, girls and women. By introducing walking cricket, we aim to appeal to all.</p>
