## **15/25 REPAYMENT OF PWLB LOAN**

## **16/25 SMALL GRANTS**

I. The committee noted the small grant award of £495 to the Firepit Foodies which was made under delegated authority.

II. The Committee noted the budget remaining for the remainder of the financial year is £4505.

III. The Committee considered the following small grant application:

3 Counties Vineyard Church - **£950**

Project description: **Community Sunday Funday**

Previous grants from HTC: **None**

The committee discussed whether or not this was a genuine community event or only open to members of the church. It would appear that it is open to all and is organised to support local residents who may not be able to afford summer holiday activities for their families. The committee asked that if the organisation applies for funding in future, more and clearer information is supplied. The committee was mindful that the council only awards the full cost of events in exceptional circumstances, and that no case for that had been made by the applicant.

**RESOLVED:** That a grant of £700 is awarded for the Community Sunday Funday.
